Exclusions from 90 Day, Limited One Year and Two Year Warranty

Warrantor shall have **no** responsibility under this warranty for any wear components, including, but not limited to: belts, blade guides, blades, electric motor brushes, drum switches, filters, fuses, hoses, bearings (excluding cylindrical drive bearings), bushings, cable carriers, and spark plugs. All wear components are furnished **"as is"**, without any warranty from Warrantor. This limited warranty does not cover any defects caused by misuse, negligence, alterations, damage due to overload, abnormal conditions, excessive operation, accident, or lack of performance of normal maintenance services.

Several components which are used in the manufacture of the equipment but not manufactured by Warrantor such as cant hooks, power plants, laser sights, batteries, tires, and trailer axles have warranties provided by the original equipment manufacturer (written copies available upon request). Warrantor does not separately warrant such items. Components or equipment manufactured by third parties are not covered by this warranty. Warrantor, however, will provide reasonable assistance to the Purchaser to make claims against any warranties applicable to such component parts as provided by such original equipment manufacturers. Components or equipment manufactured by third parties are not covered by this Warranty.

Five Year Limited Chassis Warranty

The limited five year chassis warranty described above, DOES NOT extend to (a) any damage stemming from accident, improper towing, overload, abuse, misuse, abnormal conditions, negligence, excessive operation, or lack of maintenance, (b) rust caused by exposure to corrosive atmospheric conditions, or (c) the sawmill head, carriage, axle, brakes, or any hydraulic or electrical components attached to the chassis.

Warrantor's Obligations as To Defects

In the event that the equipment fails to perform due to defective materials or workmanship attributable to Warrantor under normal use and service within the established warranty period, Purchaser's sole and exclusive remedy and Warrantor's sole liability shall be to replace or repair, in Warrantor's sole and subjective discretion, any defective part at Warrantor's principal place of business without cost to the Purchaser if such defect exists. The determination of whether a product is defective shall be made by Warrantor in Warrantor's sole and subjective discretion. The Purchaser must notify Warrantor prior to shipping any defective part. Warrantor, at its sole discretion, may cover expenses incurred in shipping the defective part to Warrantor for evaluation; provided, however, that Warrantor will not be responsible for labor, travel time, mileage, removal, installation or incidental or consequential damages. However, any part in excess of 140 pounds must be returned by the Purchaser, to the Warrantor's nearest authorized facility at the Purchaser's expense, if return is requested by Warrantor. Warrantor shall have a reasonable time within which to replace or repair the defective part. If Warrantor determines that the product is not defective under the terms of this warranty in Warrantor's sole and subjective discretion, then Purchaser shall be responsible for any expenses incurred by Warrantor in returning the equipment to the Purchaser.

Limitations and Disclaimers of Other Warranties

Rights of Purchasers

The validity and effect of this limited warranty as well as its interpretation, operation and effect, shall be determined exclusively by the principles of law and equity of the State of Indiana, USA. This limited warranty gives Purchaser specific legal rights. Purchaser may also have other rights, which may vary from state to state. Some states may not allow limitations as to the duration of implied warranties or to the exclusion or limitation of incidental or consequential damages, so some of the limitations and exclusions detailed set forth above may not apply. SECTION 2 GENERAL SAFETY

2.1 Safety Symbols

The following symbols and signal words call your attention to instructions concerning your personal safety. Be sure to observe and follow these instructions.

2.2 Safety Instructions

OWNER/OPERATOR'S RESPONSIBILITY

The procedures listed in this manual may not include all ANSI, OSHA, or locally required safety procedures. **It is the owner/operator's responsibility and not Wood-Mizer LLC to ensure all operators are properly trained and informed of all safety protocols.** Owner/Operators are responsible for following all safety procedures when operating and performing maintenance to the equipment.

Observe ALL Safety Instructions

NOTICE Read the entire Operator's Manual before operating this equipment.

Note all safety warnings throughout this manual and those posted on the machine.

Be able to access this manual at all times while operating this equipment.

Read additional manufacturer's manuals and observe their applicable safety instructions.

Only persons who have read and understood the entire operator's manual should operate this equipment.

This equipment is not intended for use by or around children.

It is the owner/operator's responsibility to comply with all applicable federal, state, and local laws, rules, and regulations regarding the ownership, operation, and transporting your equipment.

WARNING! Clean sawdust from all guards, vents, control boxes, or any area where sawdust may gather **after every shift**. Failure to do so may result in fire, causing death or serious injury.

EQUIPMENT SETUP

Coastdown required. Shut down the conveyor and allow all moving parts to come to a complete stop before removing any guards or covers.

KEEP SAFETY LABELS IN GOOD CONDITION

NOTICE Ensure that all safety decals are clean and readable. Replace all damaged safety decals to prevent personal injury or damage to the equipment. Contact your local distributor, or call your Customer Service Representative to order more decals.

NOTICE If replacing a component that has a safety decal affixed to it, ensure the new component also has the safety decal affixed in the same place.

KEEP AREA CLEAN



WARNING! Maintain a clean and clear path for all necessary movement around the material stacking areas.

Do not allow children in the area.

DISPOSE OF WOOD BY-PRODUCTS PROPERLY

NOTICE Properly dispose of all wood by-products, including sawdust, chips, and other debris, including operation waste such as oil, filters, etc.

2.3 Electrical Lockout Procedures

RULES FOR USING LOCKOUT PROCEDURE

The equipment shall be locked out to protect against accidental or inadvertent operation when such operation could cause injury to personnel. Do not attempt to operate any switch or valve bearing a lock.

LOCKOUT PROCEDURES MUST BE USED DURING, BUT NOT LIMITED TO:

- Changing or adjusting blades
- Unjamming operations
- Cleaning
- Mechanical repair
- Electrical maintenance
- Retrieval of tools/parts from work area
- Activities where guards or electrical panel guard is open or removed

MAINTENANCE HAZARDS INCLUDE, BUT NOT LIMITED TO:

- Blade contact
- Pinch points
- Kickbacks
- Missiles (thrown blades/wood chips)
- Electrical

FAILURE TO LOCKOUT MAY RESULT IN, BUT NOT LIMITED TO:

- Cut
- Crush
- Blindness
- Puncture
- Electrocution
- Serious injury and death
- Amputation
- Burn
- Shock

TO CONTROL MAINTENANCE DANGERS:

- Lockout procedures must be followed (see **OSHA regulation 1910.147**).
- Never rely on machine stop control for maintenance safety (emergency stops, on/off buttons, interlocks).
- Do not reach into moving blades or feed systems. Allow all coasting parts to come to a complete stop.
- Electrical power supply and air supply must both be locked out.
- Where established lockout procedures cannot be used (electrical troubleshooting or mechanical dynamic troubleshooting), alternative effective protective techniques shall be employed which may require special skills and planning.
- Always follow safe operations practices in the workplace.

EQUIPMENT LOCKOUT PROCEDURE

Lockout procedures per OSHA regulation 1910.147, appendix A:

GENERAL

The following simple lockout procedure is provided to assist owner/operators in developing their procedures so they meet the requirements of **OSHA regulation 1910.147**. When the energy isolating devices are not lockable, tagout may be used, provided the owner/operator complies with the provisions of the standard which require additional training and more rigorous periodic inspections. When tagout is used and the energy isolating devices are lockable, the owner/operator must provide full operator protection (see OSHA regulation 1910.147, paragraph (c)(3)) and additional training and more rigorous periodic inspections are required. For more complex systems, more comprehensive procedures may need to be developed, documented, and utilized.

PURPOSE

This procedure establishes the minimum requirements for the lockout of energy isolating devices whenever maintenance or servicing is done on machines or equipment. It shall be used to ensure that the machine or equipment is stopped, isolated from all potentially hazardous energy sources and locked out before personnel perform any servicing or maintenance where the unexpected energization or start-up of the machine or equipment or release of stored energy could cause injury.

COMPLIANCE WITH THIS PROGRAM

All personnel are required to comply with the restrictions and limitations imposed upon them during the use of lockout. The authorized personnel are required to perform the lockout in accordance with this procedure. All operators, upon observing a machine or piece of equipment which is locked out to perform servicing or maintenance shall not attempt to start, energize, or use that machine or equipment.

SEQUENCE OF LOCKOUT

1. Notify all affected personnel that servicing or maintenance is required on a machine or equipment and that

the machine or equipment must be shut down and locked out to perform the servicing or maintenance.

2. The authorized employee shall refer to the company procedure to identify the type and magnitude of the energy that the machine or equipment utilizes, shall understand the hazards of the energy, and shall know the methods to control the energy.
3. If the machine or equipment is operating, shut it down by the normal stopping procedure (depress the stop button, open switch, close valve, etc.).
4. De-activate the energy isolating device(s) so that the machine or equipment is isolated from the energy source(s).
5. Lock out the energy isolating device(s) with assigned individual lock(s).
6. Stored or residual energy (such as that in capacitors, springs, elevated machine members, rotating flywheels, hydraulic systems, and air, gas, steam, or water pressure, etc.) must be dissipated or restrained by methods such as grounding, repositioning, blocking, bleeding down, etc.
7. Ensure that the equipment is disconnected from the energy source(s) by first checking that no personnel are exposed, then verify the isolation of the equipment by operating the push button or other normal operating control(s) or by testing to make certain the equipment will not operate.



CAUTION! Return operating control(s) to neutral or "off" position after verifying the isolation of the equipment.

8. The machine or equipment is now locked out.

RESTORING EQUIPMENT TO SERVICE

When the servicing or maintenance is completed and the machine or equipment is ready to return to normal operating condition, the following steps shall be taken.

1. Check the machine or equipment and the immediate area around the machine to ensure that nonessential items have been removed and that the machine or equipment components are operationally intact.
2. Check the work area to ensure that all personnel have been safely positioned or removed from the area.
3. Verify that the controls are in neutral.
4. Remove the lockout devices and re-energize the machine or equipment.

NOTE: The removal of some forms of blocking may require re-energization of the machine before safe removal.

5. Notify affected personnel that the servicing or maintenance is completed and the machine or equipment is ready for use.

PROCEDURE INVOLVING MORE THAN ONE PERSON

In the preceding steps, if more than one individual is required to lock out the equipment, **each shall place his own personal lock on the energy isolating devices.**

SECTION 4 SETUP

The conveyor transfers material in only one direction, but can temporarily run in the reverse direction to clear jams.

The middle section can be repeated in sequence to extend the length of the conveyor.



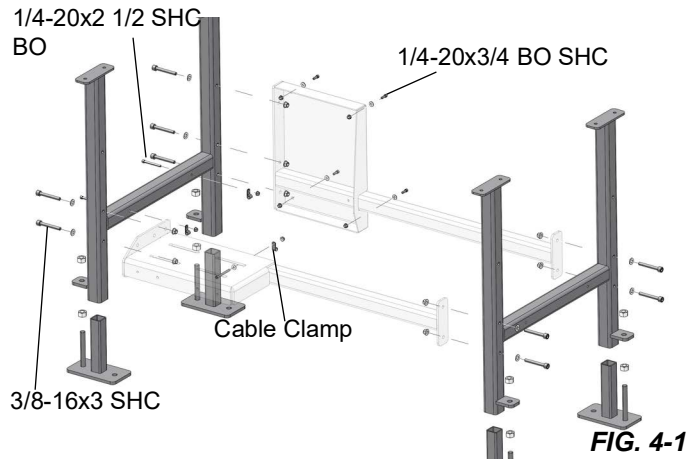
WARNING! Use two or more people when lifting loads heavier than 50 pounds.



Prepare a firm, level area where the deck can be anchored. A cement pad with 1/2" diameter anchor bolts is recommended.

4.1 Drive Section

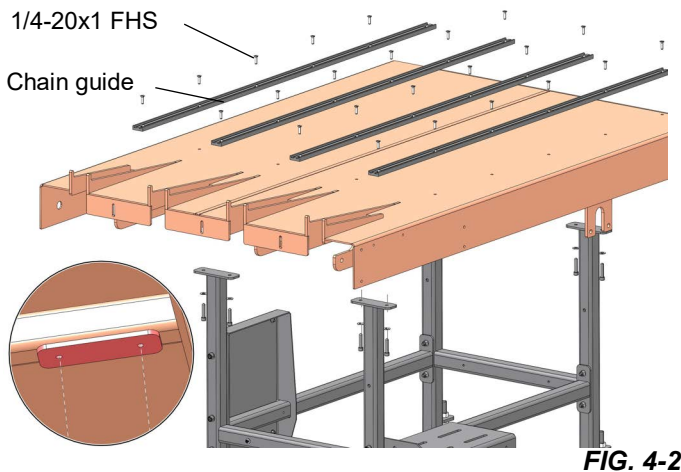
1. Assemble the adjustable feet to the table legs as shown in FIG. 3-1.



WARNING! Use two or more people when lifting loads heavier than 50 pounds.



2. Assemble the chain guide channels and leg supports to the table as shown in FIG. 4-2.

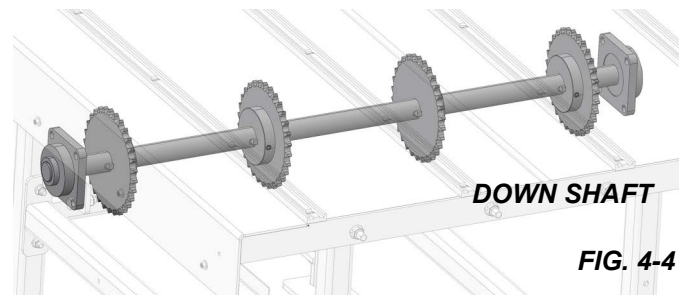
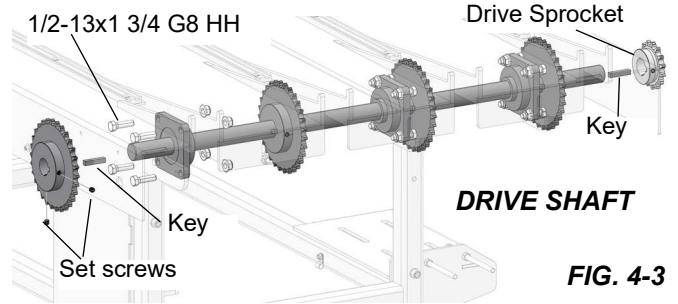


NOTE: The legs fit on plates welded onto the table bottom.

3. Loosen (**do not remove**) the set screws on all sprockets.
4. Slide the bearings and sprockets onto the chain drive shaft **in the order and orientation** as shown in FIG. 3-3 and FIG. 4-4.

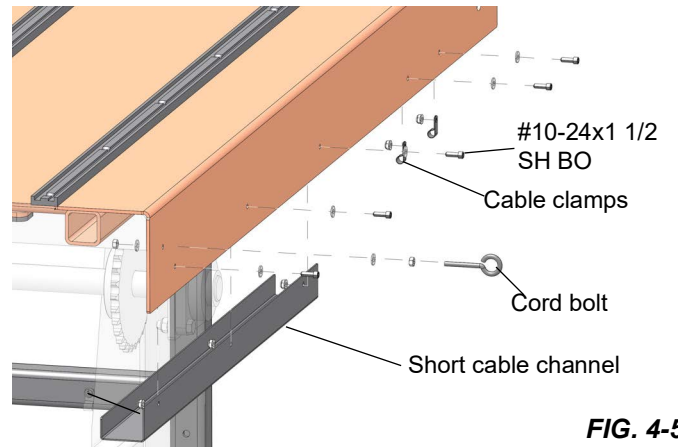
NOTE: The bolts securing the bearings must be in place before the sprockets are in place.

5. Ensure that the sprocket keys aligns properly in the shaft and sprocket for all sprockets.



IDLE SIDE

6. Install cable channel and clip to the underside of the table.
7. Install the emergency cord bolt to the side of the table.



DRIVE SIDE

8. Install the emergency cord bolt on the drive side in the same manner as shown in FIG. 4-5.

9. Screw one nut on each motor adjustment bolt before inserting into the motor mount shelf. See FIG. 4-6.

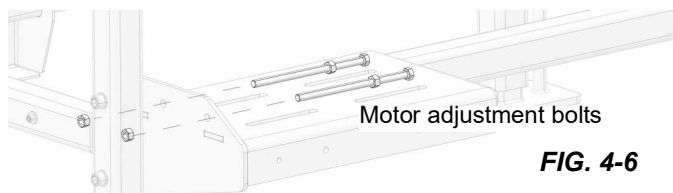

10. Prior to mounting, add 28 oz. of Mobil Glygoyle 460 Gear Oil and install the vent plug.
11. Bolt down the gear motor to the shelf, but do not tighten securely yet. See FIG. 4-7.
12. Bolt the back cover to the frame as shown in FIG. 4-7.
13. Loosen the sprocket set screws and place the sprocket and the key on the gear shaft.
14. Wrap the drive chain around the drive sprocket on the drive shaft (FIG.4-3) and the gearbox sprocket; secure the chain with the master link.

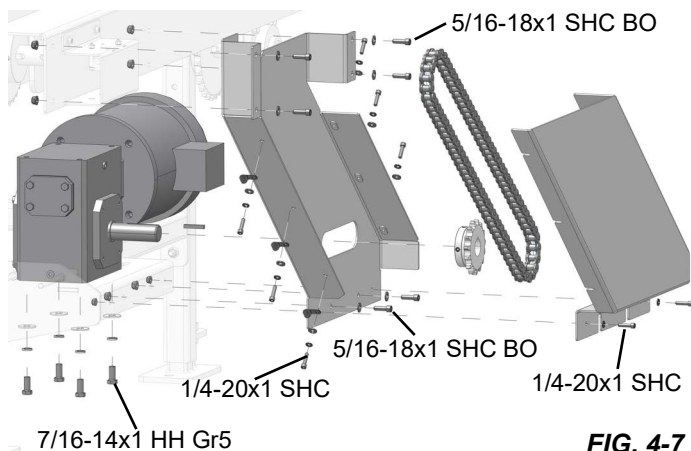

15. Use the adjustment bolts to tension the chain on the sprockets as shown in FIG. 4-6.

NOTICE Do not over tension the drive chain. Damage will occur. Allow up to 1/2in (12mm) of slack in the chain.

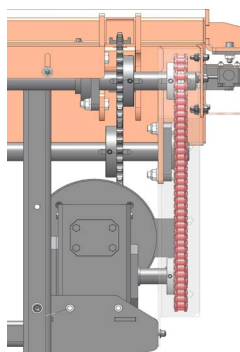

16. Tighten the sprocket set screws and gearbox mounting bolts when the drive chain is properly aligned and tensioned.

17. Install the front drive chain cover.

ELECTRICAL BOX

1. Mount the electrical box to the frame by the 4 bolts at the inside corners of the box as shown in FIG. 4-9.

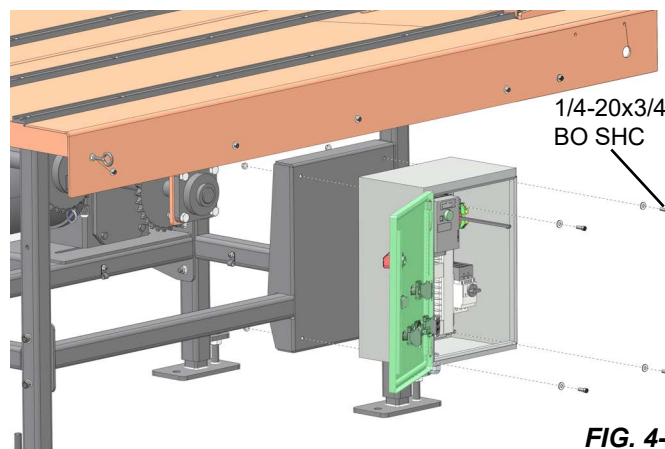

4.2 Middle Section

Multiple middle sections can be installed in series to increase the length of the conveyor.

1. Assemble the middle in the same manner as the drive section.
 - 1). Assemble the down shaft as shown in FIG. 4-4.
 - 2). Assemble the chain guides as shown in FIG. 4-2.
 - 3). Assemble the cable channel and cord bolt as shown in FIG. 4-5.
 - 4). Assemble the down shaft to the table.

- 5). Install the table to the table legs as shown in FIG. 4-2.

Connect the Drive and Middle Sections

1. Install the assembled middle section to the drive section as shown in FIG. 4-10.

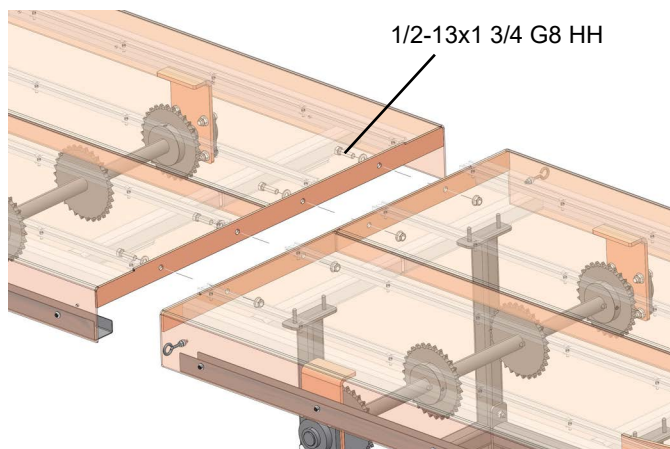

 - 2). Assemble the chain guides as shown in FIG. 4-2.
 - 3). Assemble the cable channel as shown in FIG. 4-5.

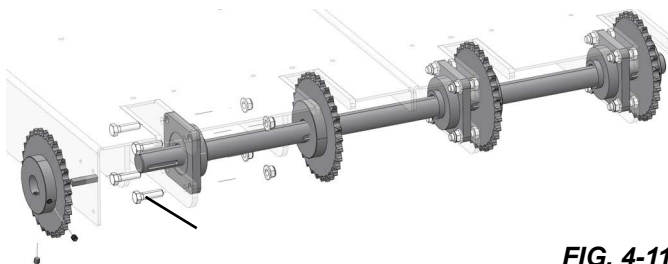

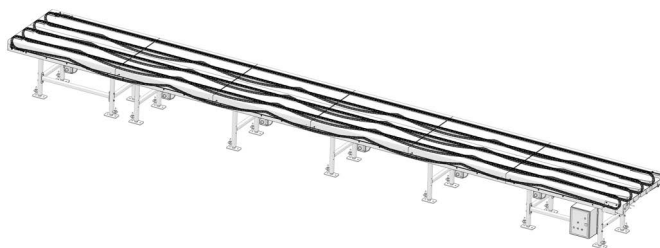

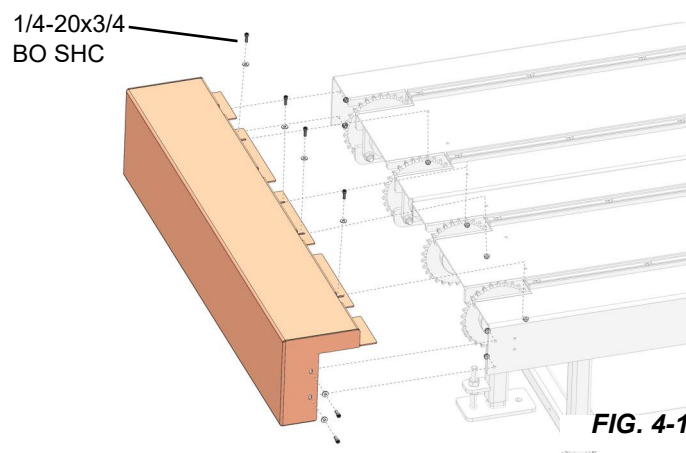

4.4 Safety Switch

1. Install the emergency cable bracket and cable on the end table on both sides of the conveyor.

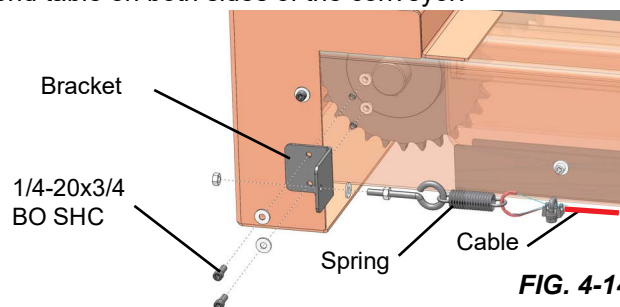

3. Install the safety switch, cover, and cable as shown in FIG. 4-15.

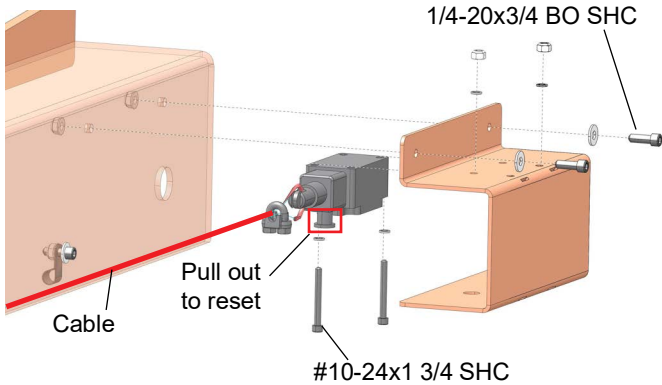

 - 5). Trip the switch with the chains running; chains should stop.

4.5 Optional Board Chute

NOTE: The board chute is best installed in place.

1. Install the adjustable feet to the legs.
2. Place the legs on opposite sides of the table.

3. Install the board chute to the legs.
4. Install the board chute fence to the board chute.

NOTE: The board chute fence can be installed on either side of the board chute.

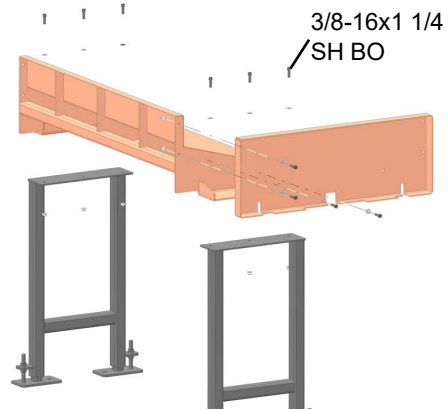

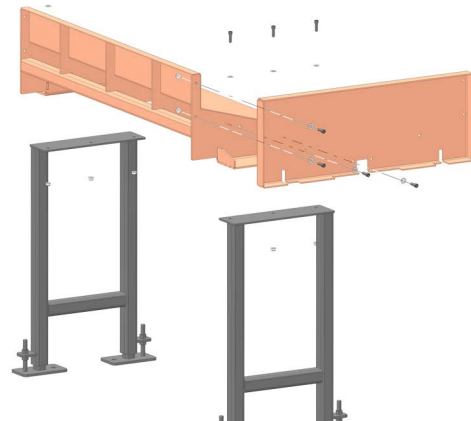

SECTION 5 OPERATION

5.1 Operation Check



DANGER! Electrical installation and adjustments must be done by a qualified electrician.



WARNING! Secure all loose clothing, hair, and jewelry before operating the equipment.

Do not adjust the motor drive chain with the motor running.

Ensure the drive chain guard is in place and secured before operating the conveyor.

1. Ensure the conveyor has been properly set up.
2. Ensure the motor drive chain is tensioned properly.
3. Ensure the drive chain guards are in place and secured.
4. Turn off the motor to stop the transfer chains whenever the conveyor is not in use.
5. Ensure that all parts have stopped moving and the unit is electrically locked out before removing any covers or guards.

5.2 Power

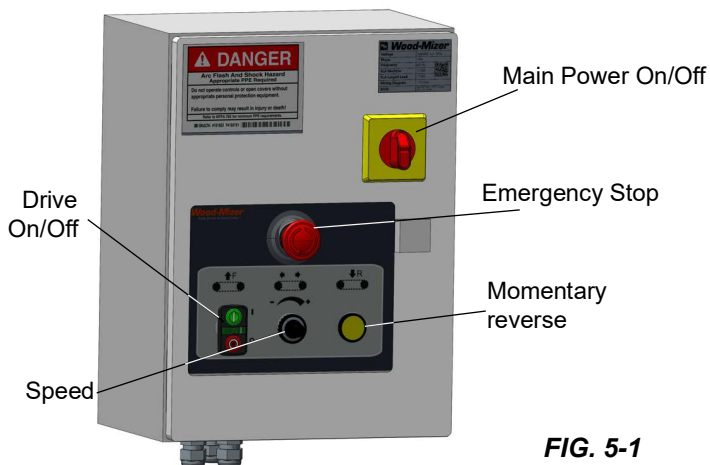

1. Turn main power on or off to the unit by turning the red power knob.
2. Turn motor power on or off by toggling the switch.

NOTE: Motor switch glows green while motor is running.

3. Set the conveyor speed by turning the speed knob.

NOTE: The conveyor must come to an normal (non-emergency) stop before reversing.

4. Press and hold the yellow button to momentarily reverse the transfer chains.

The Emergency Stop should only be used for emergencies. If used, it must be rotated clockwise and pulled out before resetting.

5.3 Safety Cable

An emergency safety cable runs the length of the conveyor on both side.

Pull the cable to stop the all operation on the conveyor.

Reset the safety switch by pulling down on the blue (color not shown) toggle switch as shown in FIG. 5-2.

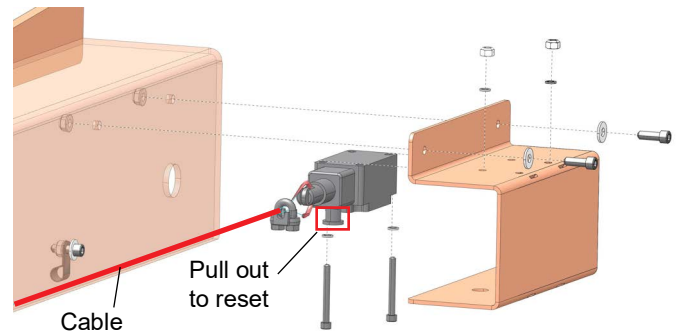

NOTE: If the switch is tripped or not reset the conveyor will refuse to start.

SECTION 6 MAINTENANCE



DANGER! Turn off and disconnect power supply before performing any service to the unit.



WARNING! Take proper protective measures against rotating shafts, pulleys, fans, etc.

Stay a safe distance from rotating members so that loose clothing or long hair does not engage rotating members.

Wear proper safety equipment (eye, ear, hand, breathing, or foot) when performing service functions.

6.1 Tensioning the Drive Chain

1. Periodically check and adjust the drive chain tension.
2. Remove the drive cover to the drive chain housing and remove the drive cover.
3. Loosen (do not remove) the four mounting bolts securing the gearbox to the gearbox mount bracket.
4. Move the gearbox/motor assembly until the center of the chain sags approximately 1/2" (12 mm).



CAUTION! Do not over-tension the drive chain. Damage to the gearbox will occur.

5. Retighten the gearbox mounting bolts.
6. Replace the drive cover to the drive chain housing.

6.2 Belt Alignment

1. Periodically check and realign the belt if necessary.
2. Make sure the belt remains centered on the rollers while running.
3. Loosen the jam nut on one or both lower roller belt tensioner bolts.
4. Turn the tensioner bolts to tension or loosen the belt.
5. Tighten the jam nuts and start the drive motor to check if the belt still needs to be aligned.
6. Repeat the steps until the belt stays in place on the rollers while running.
7. Retighten the jam nuts when the belt alignment procedure is complete.

NOTE: You can also use the adjustment bolt securing one side of the drive roller to align the belt. To align the belt, loosen the jam nut and turn the adjustment bolt to align the belt as necessary. Make sure the belt remains centered on the drive roller while operating the . Also, make sure the drive chain is properly tensioned after tightening the adjustment bolt and jam nut.

6.3 Check Chain Wear

1. Periodically check the chains or chain guides for wear; replace as needed.
2. Always check the belt alignment after installing a new belt.

6.4 Check the Sprockets

Check the sprockets every 8 hours of operation. Remove any dirt or debris.

6.5 Gearbox Oil

Check the gearbox oil level in the gearbox periodically.

Add a synthetic gear oil such as Mobil Glygoyle 460 to the gearbox as needed.

CHANGE GEARBOX OIL

1. Drain and refill the gearbox every 6000 hours of operation or every 2 years, whichever comes first.
2. Use 28 ounces (0.83L) of Mobil Glygoyle 460 oil to refill the gearbox.
3. Change oil every time when performing maintenance that requires gearbox disassembly.
4. Wood-Mizer offers replacement gear oil in 8 ounce (0.24L) bottles.

6.6 Lubrication

Lubricate the roller bearings every 200 hours of operation with one to two pumps of high-quality lithium-based grease such as Shell Alvania No. 3. **Do not over-grease.**
